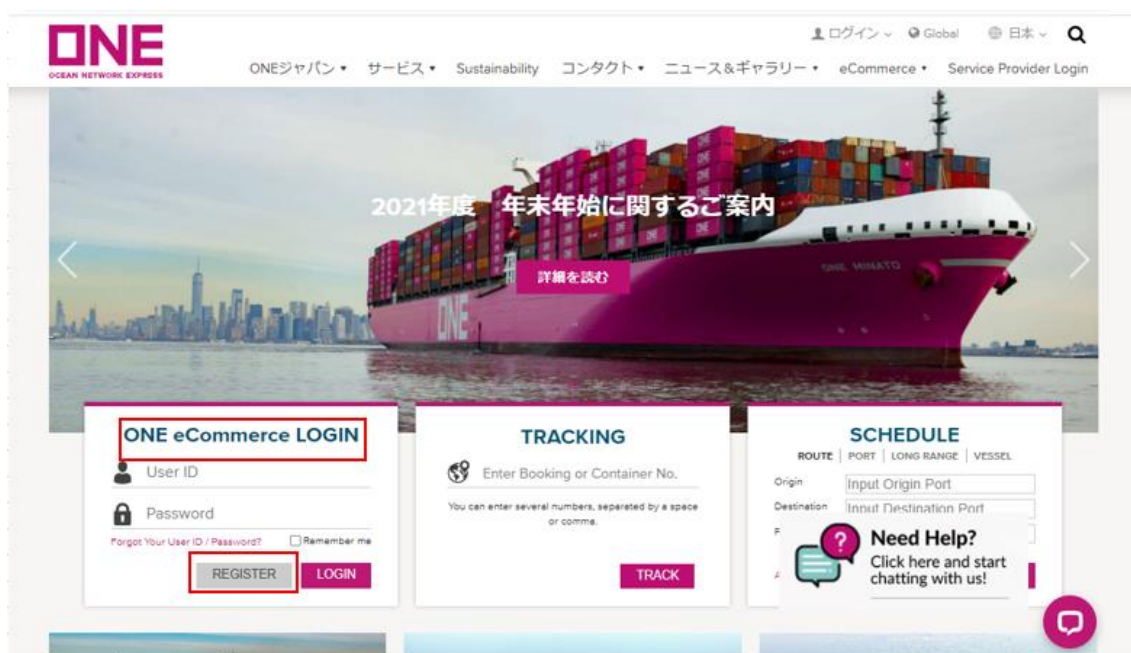


【ID の登録方法】

USER INDEMNITY AGREEMENT

Agreement between ONE and the party specified on the registration form.

In consideration of ONE giving User a password ("Password") to enable User to have access to certain confidential shipment information accessible and obtainable via ONE's web site on the Internet ("Information") or on ONE Mobile Application, including but not limited to quotation, booking data, freight data, B/L data, and container tracking data with respect to shipments with ONE, User hereby agrees as follows:

1. User shall keep ONE's Password and all information with respect to shipments and quotation with ONE confidential, and not reveal them to any third party except ONE's directors, officers and employees (and, as to information with respect to particular shipment(s), except broker, forwarder, shipper, consignee and/or notify party of such shipment(s)). We shall further ensure that such directors, officers, and employees keep ONE's Password and all such information confidential and not reveal them to any third party.
