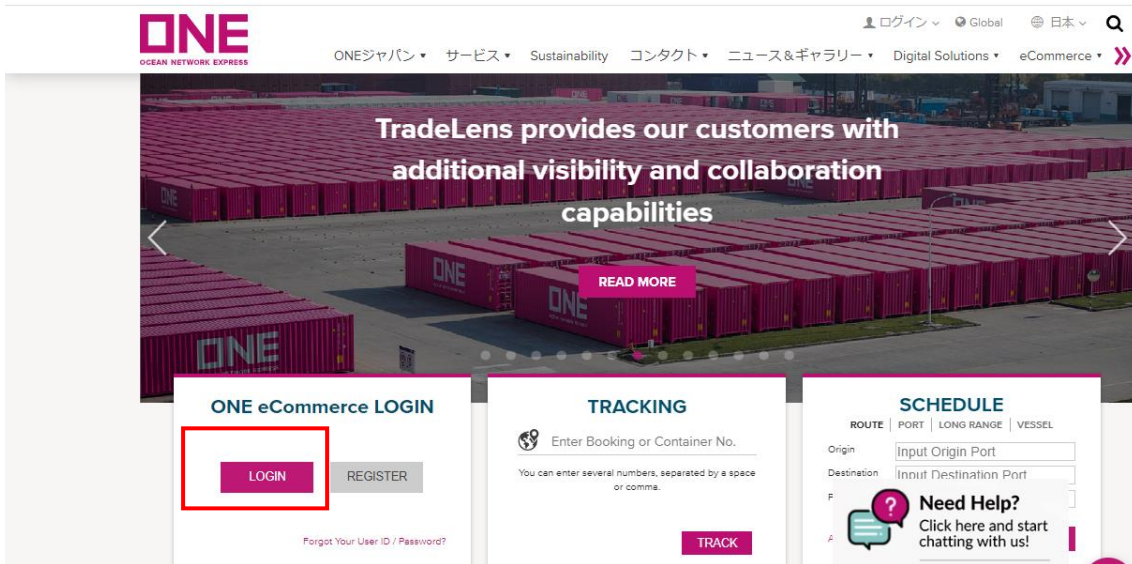
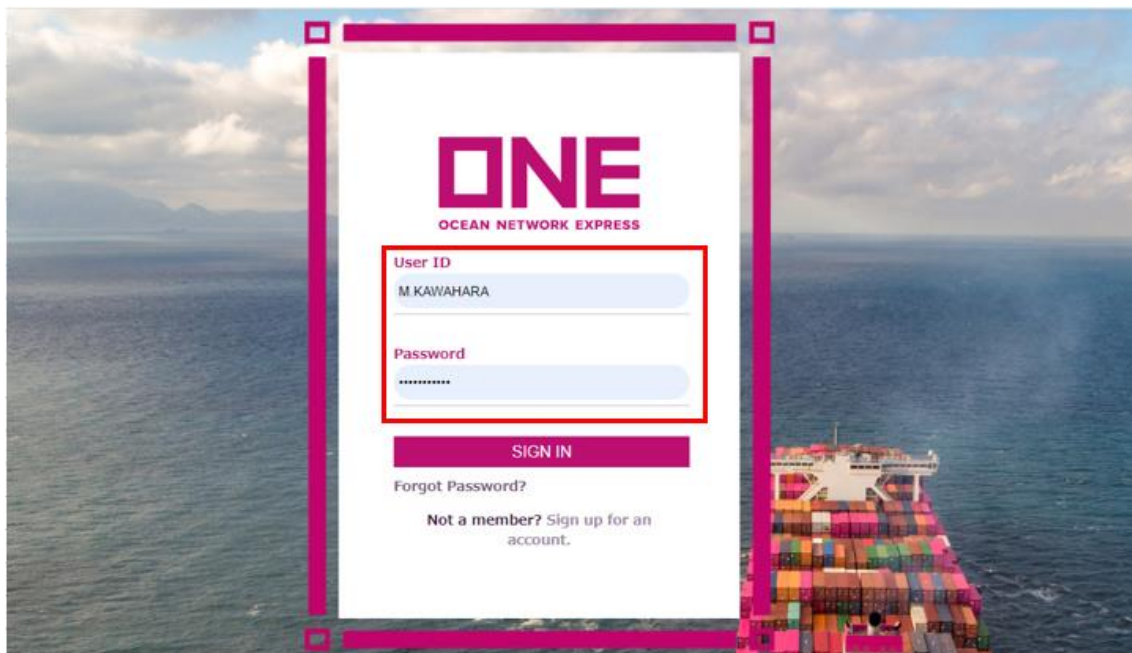


【ログイン手順】

2. 左下の ONE eCommerce LOGIN の LOGIN をクリックください。

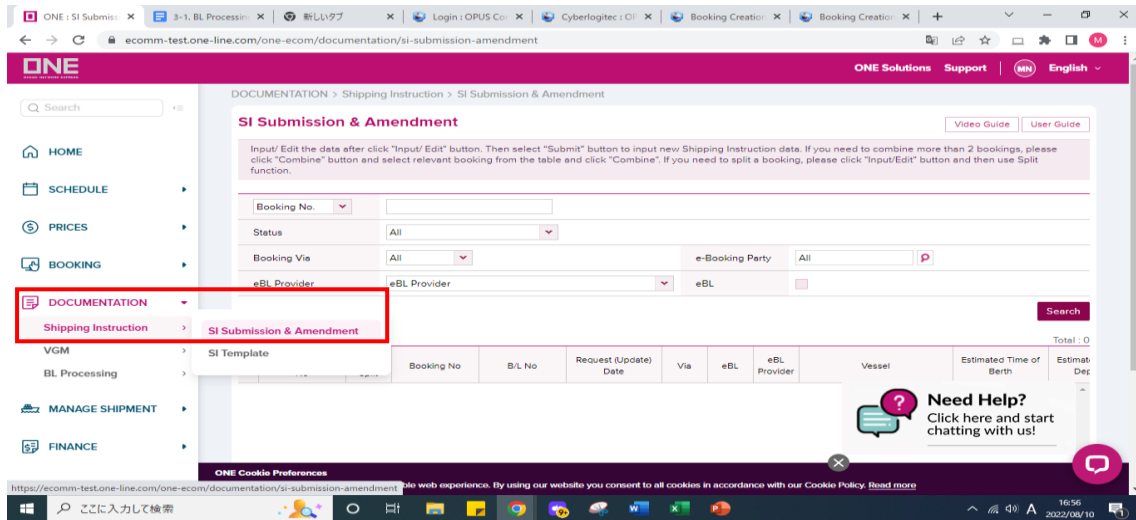


3. 下記画面に映りますので、ID とパスワードが入っていることを確認の上、SIGN IN をクリックください。

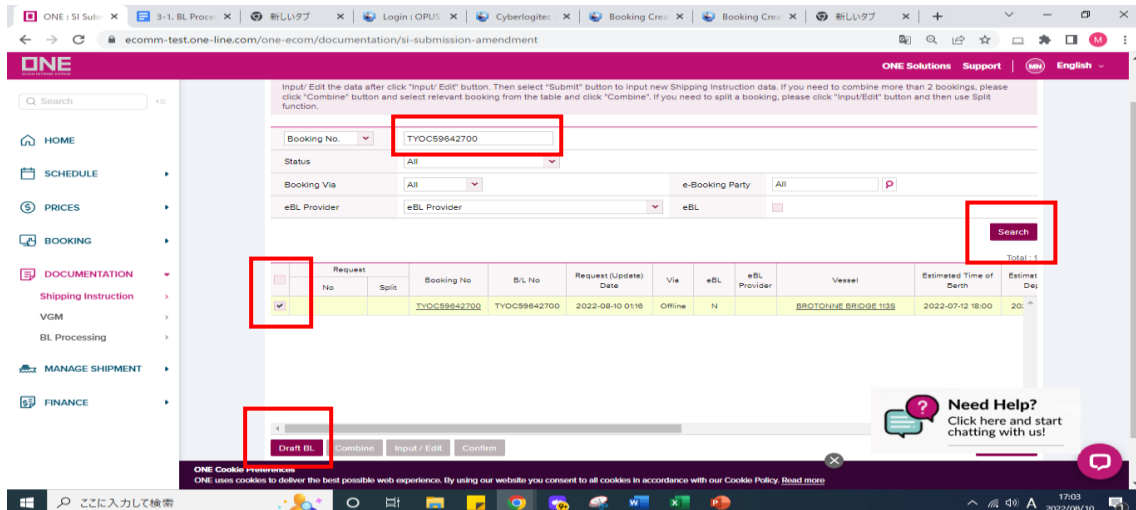


【本船出港前に BL ドラフト（フレートメモ）を出力したいとき】

「Shipping Instruction>>SI Submission & Amendment」をクリックします。

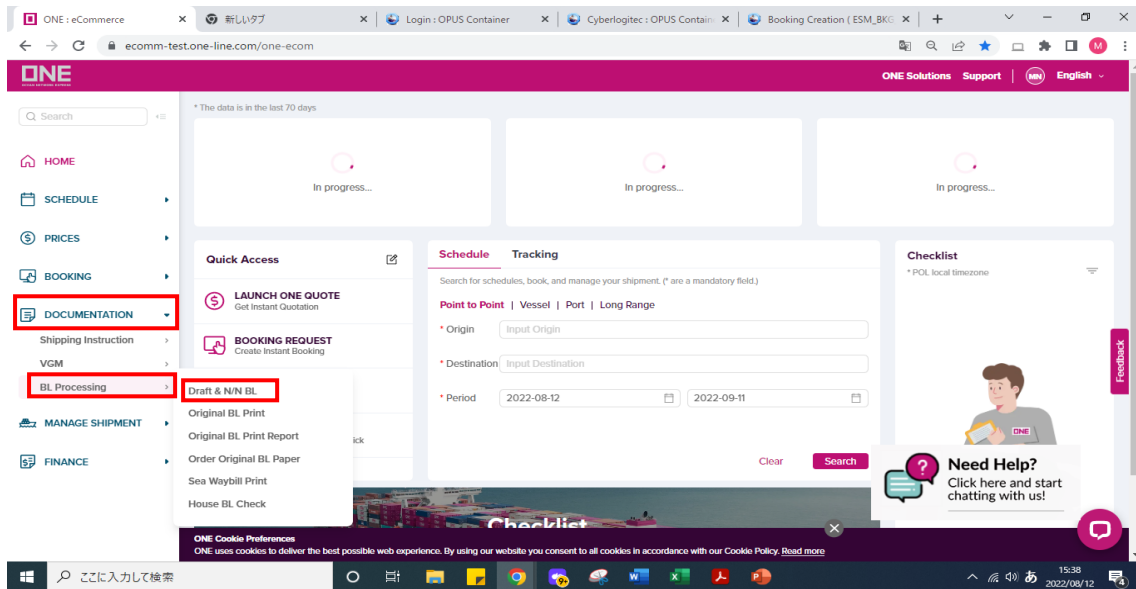


2. 画面中央上に該当の BOOKING NO を入力し、右端の Search をクリックします。

次に「 BL processing>>Draft & N/N BL」をクリックします。

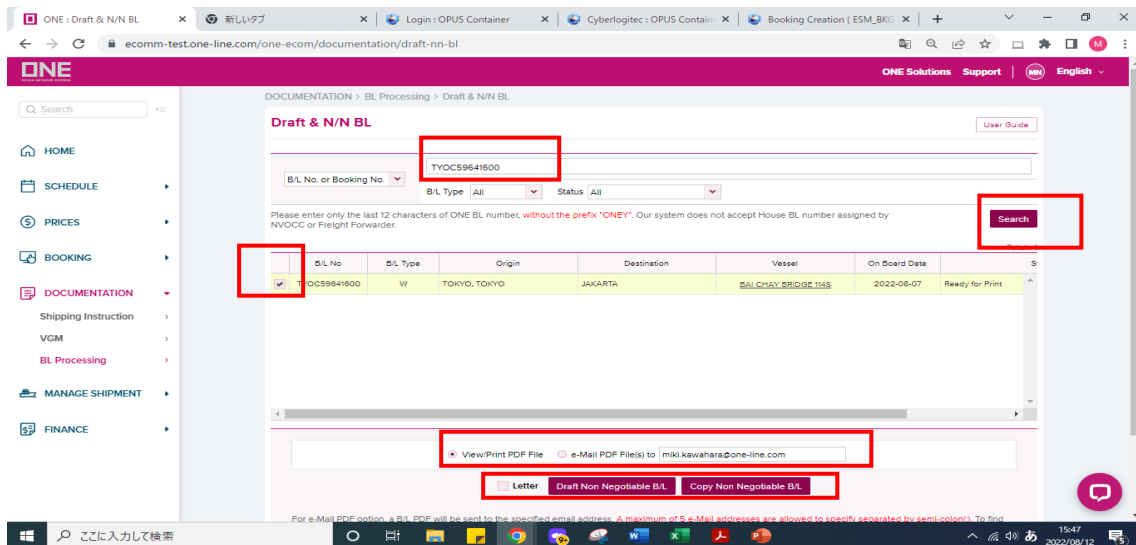

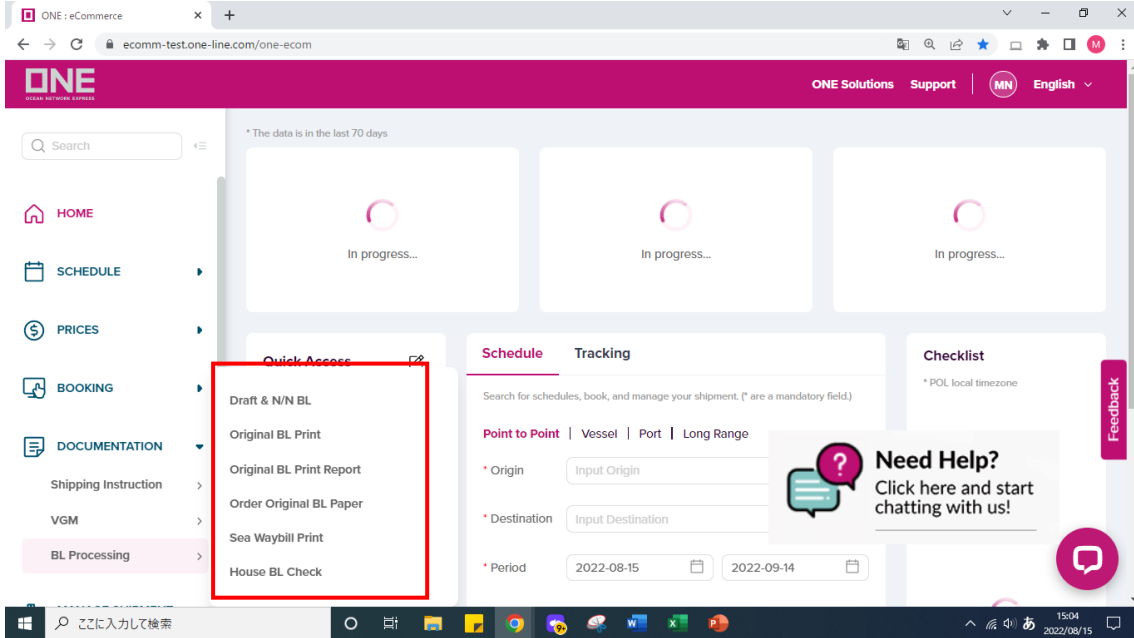
